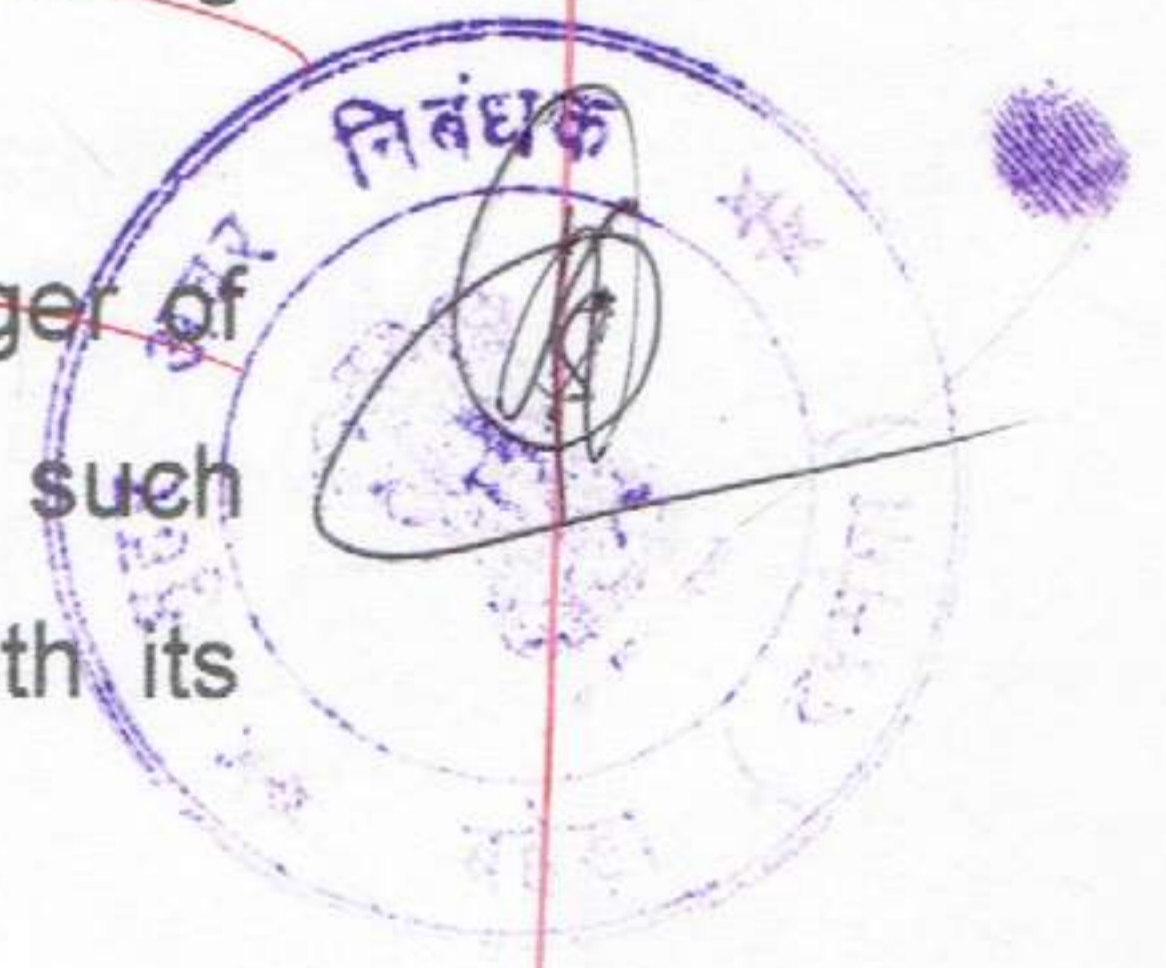


the office of the Trust shall be situated at Village- Afzala Tole Kheba, Janpatti, Dumari Road, P.S- Biraul, Distt.- Darbhanga which may be removed from time to time to such other place or places as the Trustees may deem fit and proper at their direction.

2. The Trust hereby create is a non-profit benevolent institution established for the purpose mentioned above without any proprietary right either of the "author" or the Trustees over the Trust property.
3. The objects of the Trust shall be –
 - (a) To establish, erect, construct building for educational institutions, Hostels for needy students, health care, Institutions, old age Homes etc on payment.
 - (b) To start schools for general educational institutions for professional education such as Medical, Engineering, Technical, Management and vocational on payment.
 - (c) Social welfare in the form of education, village women empowerment by involving and encouraging them in self supporting projects on payment.
 - (d) To expend the Trust by allowing merger of the other institutions with it if such institutions are unable to continue with its

welfare and education projects, after such merger by resolution, it will be a part of the Trust estate and it will have no separate entity or existence.

4. The financial year of the Trust shall be start on 1st April and will be end on 31st March every year provided that board of Trustee shall be at liberty to change the same from time to time, if they deem fit and proper.

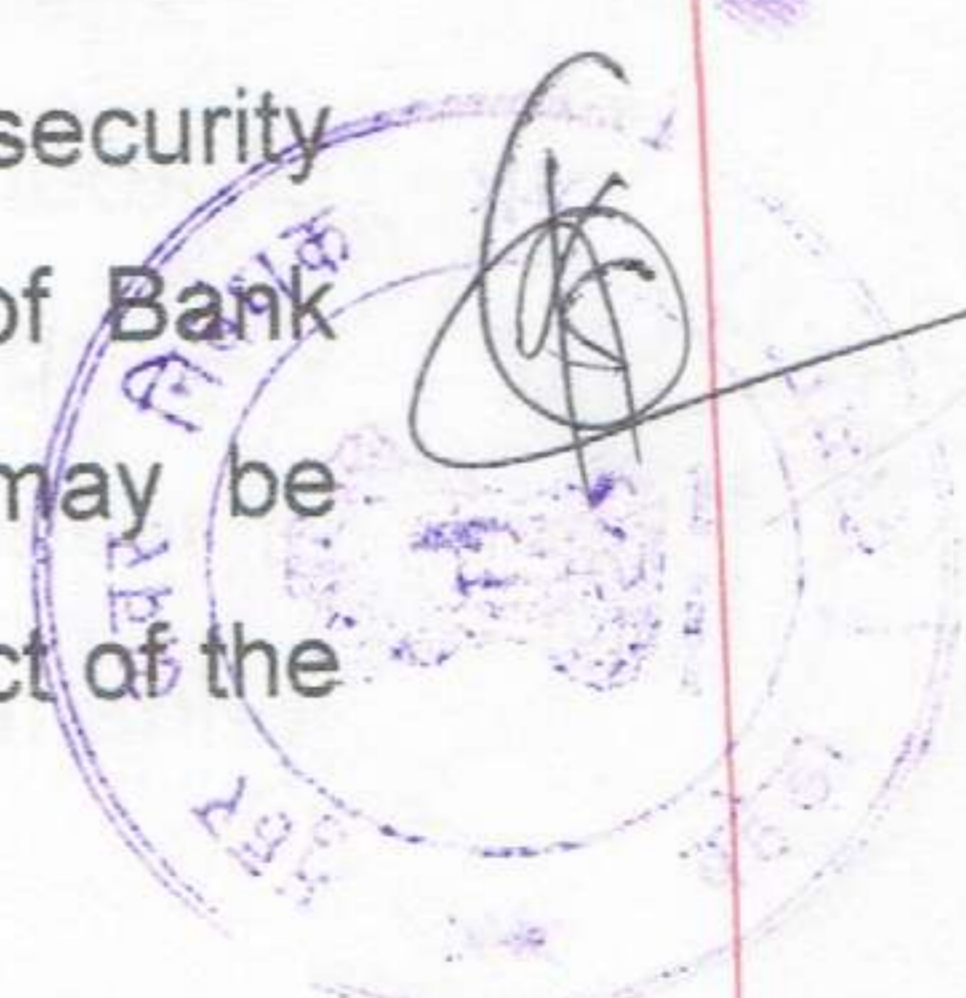
5. The Trustees from time to thime after meeting the expenses of and incidental to the management of the Trust properties and of the Trust decided the particular object or objects for which the income or corpus of the Trust fund or properties for the time being available shall be applied and shall do all acts which are reasonable and proper for the realization, protection and benefit of the Trust and the Trust properties.

6. Without affecting the generality of powers and functions to the Trustees to manage and administer the Trust, the board of Trustees shall have the following functions:

(a) To borrow if needed be against the security of the assets of the trust by way of Bank overdrafts, loan or otherwise, as may be necessary for the benefit of the object of the

(b) To accept unconditional gifts and donation of both movable and immovable properties from any kind hearted people interested in the aim and object of the Trust which shall be the trust property after acceptance.

(c) To arrange for and/or authorize the signing or execution of any agreement, contract, instrument, document or any other paper for legal purpose or writing required to be signed or executed on behalf of the Trustees by any tow of the Trustee to be nominated in this behalf by the Board of Trustees and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the Trustees.

(d) To authorize any tow or more trustees to hold any property or any fund or investment of the Trust subject however to the terms of these present in such manner

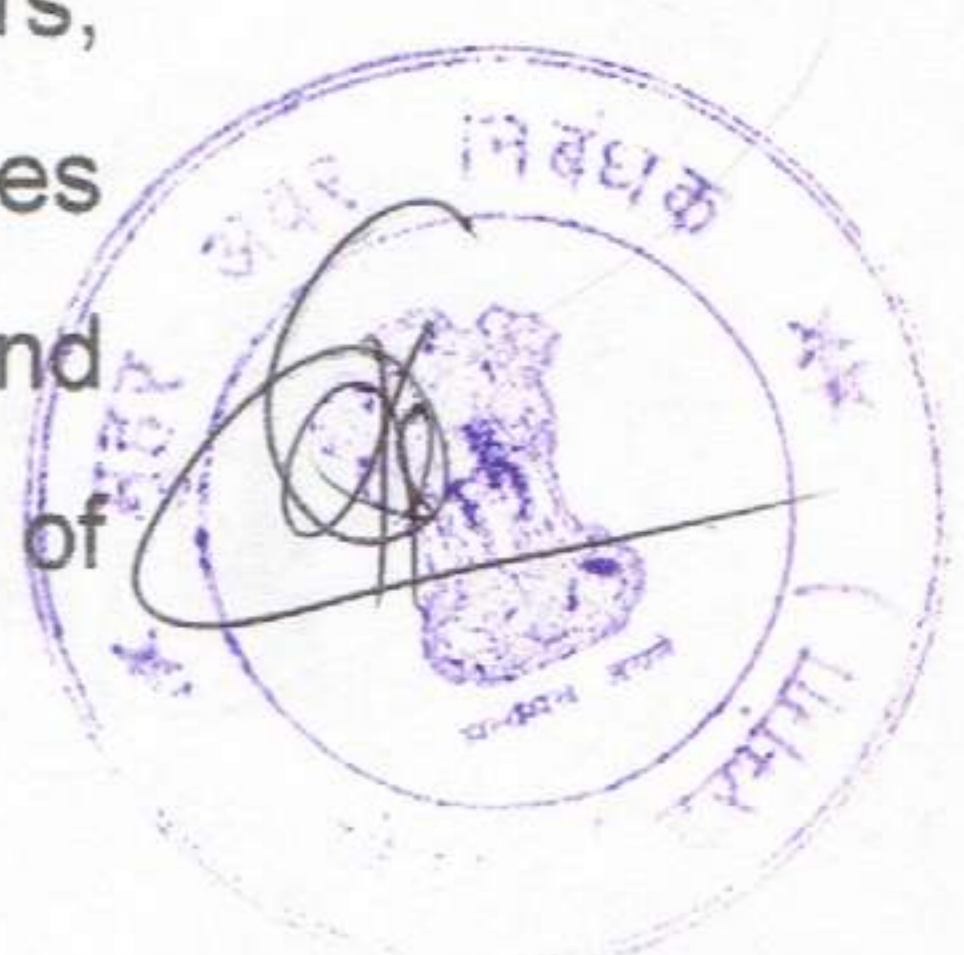


9. The Trustees shall keep account or accounts with any Bank or Banks, to operate such accounts whether in debt or in credit and to give all appropriate instructions to Banker or Bankers concerning the operation of such account or accounts and to authorize by appropriate resolution two or more of the trustees jointly appointed by the Board of Trustees in this behalf to operate such account or accounts.

10. The trustees may pay all charges and outgoing payable in respect of any immovable property for the being forming part of the trust fund and may carry out repairs required to be done to the same and keep the same insured against all or damage by fire and may incur all other costs, charges and expenses incidental to the administration and management of the Trust Estate and the properties for the time being belonging to the trust as they may in their absolute discretion think fit.

11. That trustees may appoint, secretaries/Managers, lawyers, Auditors, Architects, Engineers, Teachers, Employees for the purpose of management and supervision the Trust estate, for collection of

12. The Trustees may from time to time frame scheme and rules and regulations to carry out the objects of the Trust and for managing the affairs of the Trust and otherwise for giving effects to the objects and purposes of the Trust and to vary the same from time to time as the Trustees may in their discretion deem fit and proper.

13. All the Trustees unless they voluntarily resign or otherwise decide, shall continue to be the Trustees during the term of their natural lives.

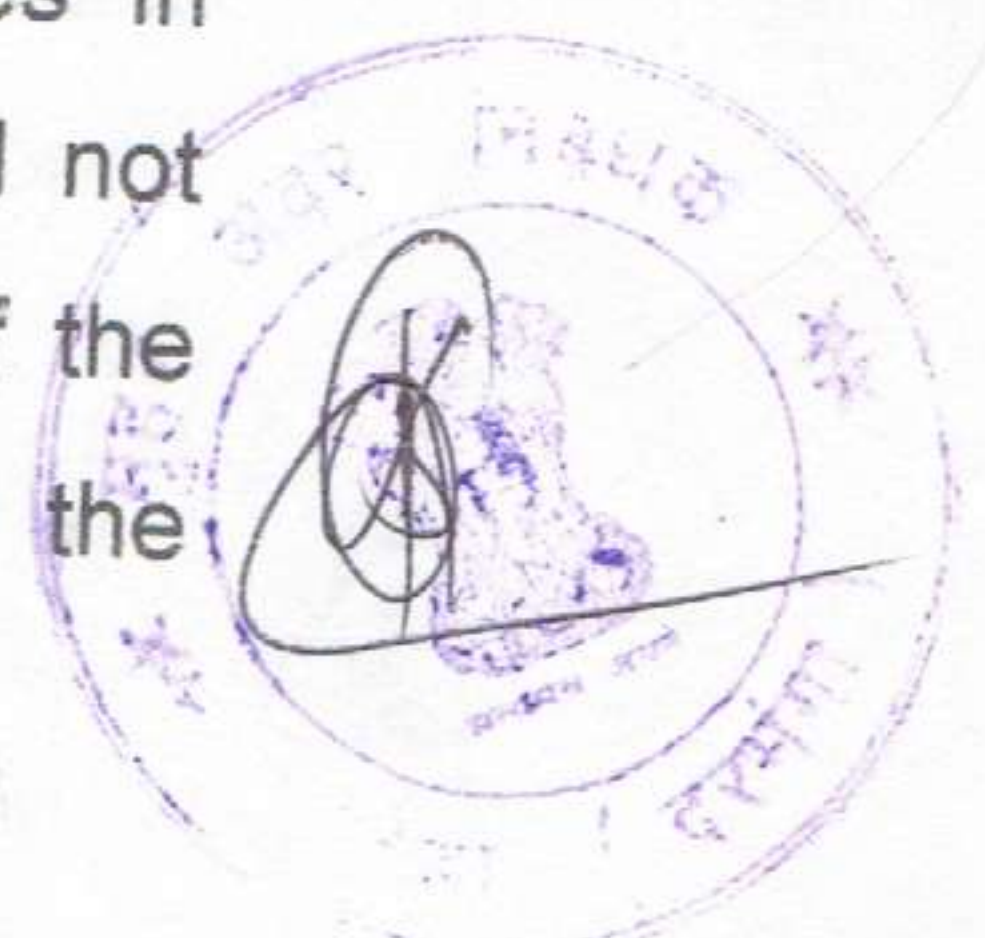
14. The member of the Trustees shall be save including the author of this deed.

minimum fixed by these presents, the Trustees shall not except for the purpose of filling any vacancy, act so long as the number is below the said minimum.

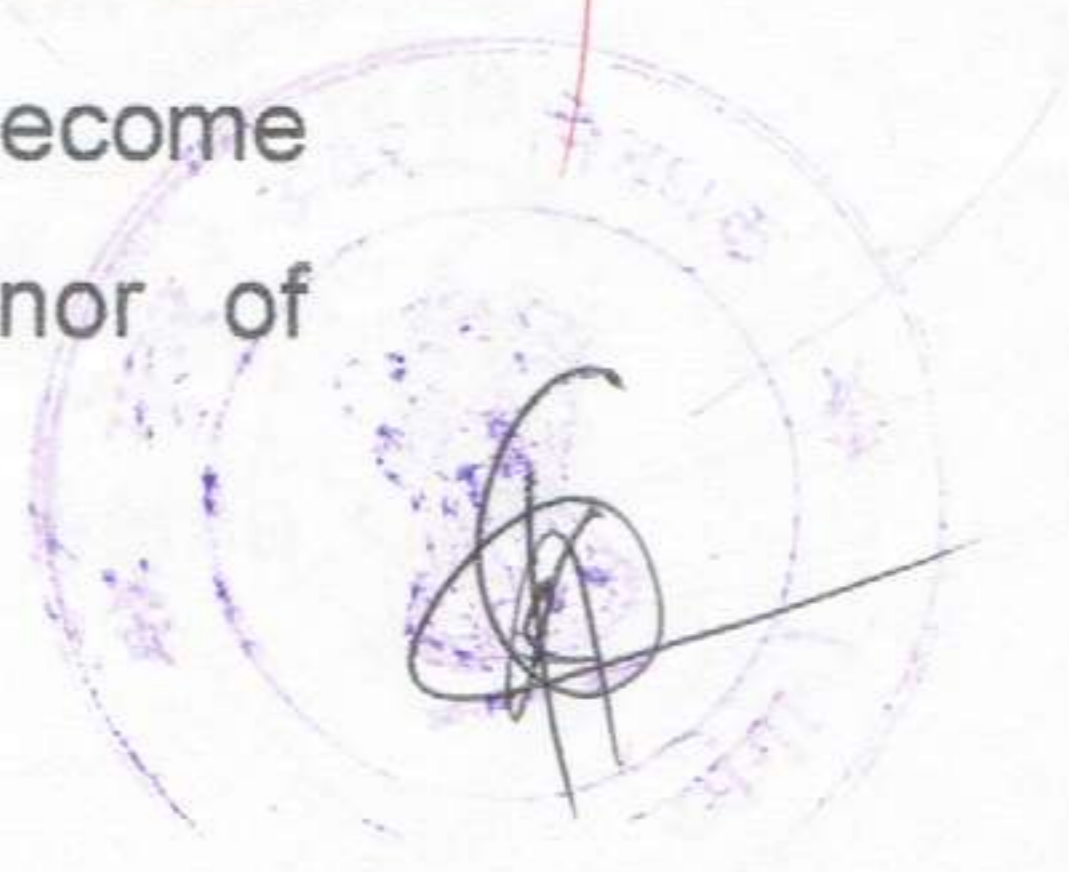
17. Majority of Trustees as a meeting shall form a quorum for any meeting of the Trustees.

18. The author of this deed will be Chairman till his life time and if he appoint any of the Trustee working at that time he will act as Chairman/Secretary of the Trust and in absence of any such things the Trustees for the time being shall elect from amongst them one Chairman/Secretary and he shall hold office for five years, unless he resigns or refused to act as chairman/Secretary or otherwise ceases to be Trustee.

19. All proceedings and questions and matters arising at the meeting of the Trustees shall be decided by a majority of the Trustees shall be decided by a majority of votes of the Trustees present other than the Chairman and in case of equality or difference of opinion of votes the Chairman shall have a right to cast vote and in case the post of Chairman become vacant, at that time the highest donor of

29. No person being (i) an discharged insolvent or (ii) convicted of an offence involving moral turpitude or (iii) of unsound mind or (iv) a minor shall be eligible to be trustee.

30. A person shall cease to be trustee in any of the following events:-

- (i) If he dies, or
- (ii) if he become bankrupt, or
- (iii) if he resigns the office, or
- (iv) if he becomes insane or otherwise become incapable to act.

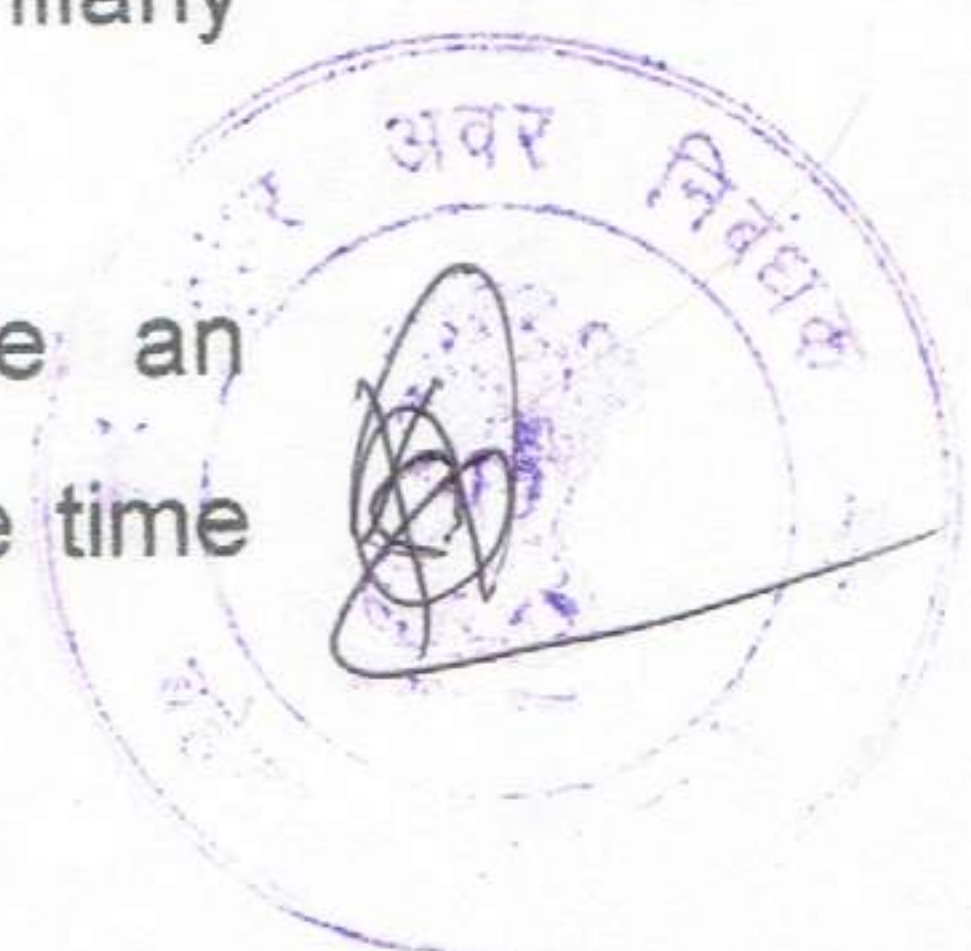
31. 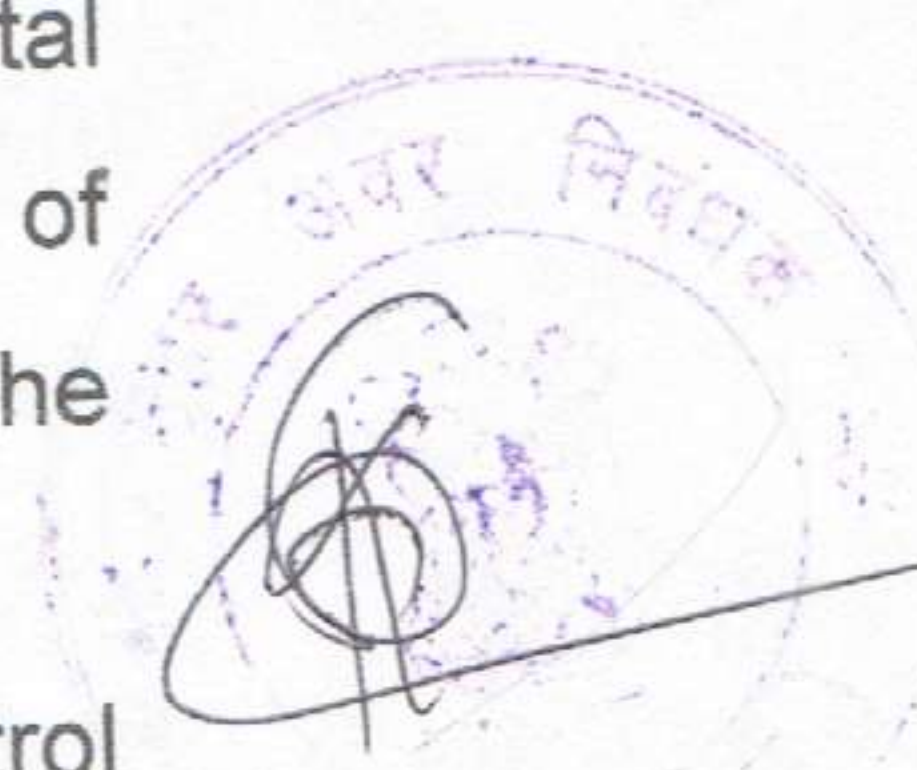
